**FORMAT:**

36 holes of Four-Ball stroke play.  
Teams play as a field. Field limited to 128 Teams.

**HANDICAP:**

April 1st handicap revision used in accordance with USGA recommendations and Slope Handicap System. Handicap indexes above the allowed maximum index of 23.2 will be adjusted down to this maximum for play in the Four-Ball tournament. The Tournament Chair reserves the right to confirm and adjust any Handicap index.

**ELIGIBILITY:**

Both contestants must be residents of Georgia and be members of GWGA. A player may join GWGA until the close of entries - March 31st.

**ENTRY:**

Enter as a team. No single entries or walk-ins accepted. Complete and mail the below Entry Form. The TOTAL TEAM FEE is \$400 and must accompany the Entry Form. This fee includes the Tournament fee, green fees, cart fees (includes Practice Round), tournament prizes, bag storage and taxes for three days and range balls for tournament days for BOTH players.

**Entries must be received by 6:00 p.m., March 31st.** Acceptance notices will be mailed/emailed after entries close to the team member with lowest handicap index. Tournament roster will be available @ [www.gwga.org](http://www.gwga.org) by April 6th.

Withdrawal BEFORE April 14th at 6:00 p.m., the TOTAL TEAM FEE (\$400) will be refunded. The TOTAL TEAM FEE minus \$60 will be refunded up to and including Saturday, April 24th. IF WITHDRAWAL AFTER THAT TIME, NO TEAM FEES WILL BE REFUNDED UNLESS THERE IS A WAITING LIST.

GWGA Tournament shall be in accordance with The USGA RULES OF GOLF and Policies and Procedures established by the Georgia Women's Golf Association.

Caddies, pull carts and private carts are not permitted. Competitors shall wear appropriate golf attire. Only non-metal spikes are permitted.

**Cell phones must be turned off on the course.**

The Board of Directors reserves the right to approve or reject entries and refund deposited monies at any time before and throughout the competition.

Distance measuring devices will be allowed to measure distance only. The use of devices that measure other conditions that might affect a players play (e.g. wind or gradient) is not permitted.
